The module has a different structure than all other modules: it contains 4 case studies, in form of interviews to privileged witnesses, without any readings.

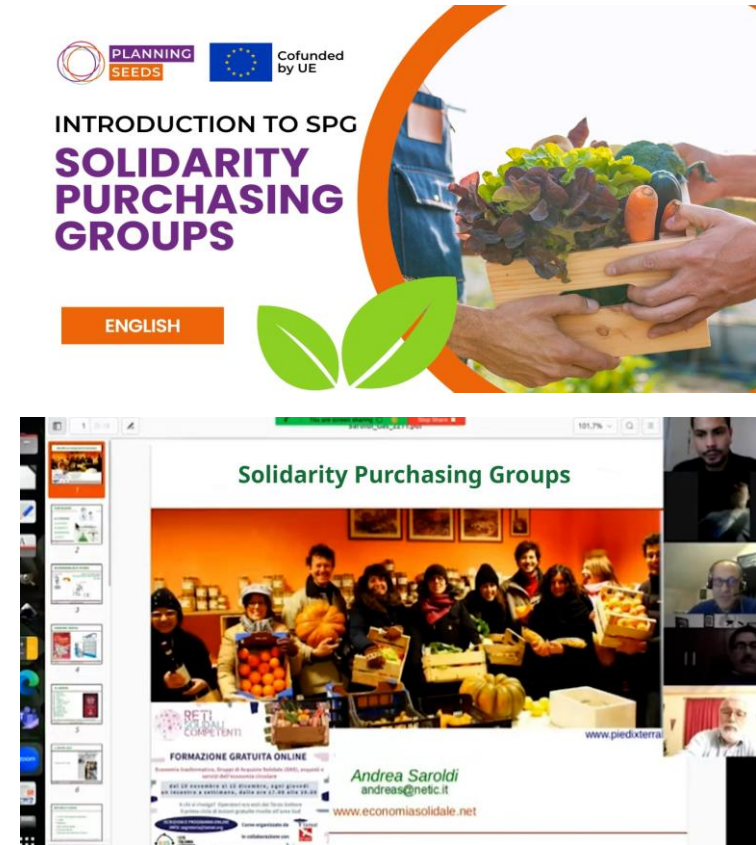

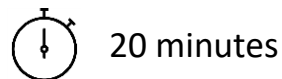
# Videos

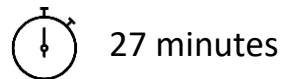
